The global biologics market is growing rapidly and is expected to grow at a rate of 10.5% in 2018-23. Novartis and Bristol-Mayers-Squibb have already invested around 700 and 900 million dollars respectively in ufacturing.

The rise in the prevalence of chronic diseases, loss of patent exclusivity, growing demand and higher acceptability for innovative therapies are driving the growth. Popularity of biologics has especially increased for chronic diseases like RA, Crohn's disease, Psoriasis and other auto-immune disorders and touched sales target of 18.5 billion dollars In 2016. Six of the top eight drugs were biological in that year. *Biocon* is projected to earn \$ 377 million in US and European markets in 2021-22. Other fields like oncology, rare diseases, infectious diseases, cell therapy, gene therapy also offer huge opportunities

The Indian biotech industry holds about 3 % share of the global biotech industry and is among the top 12 global biotech destinations. The Indian biotech industry, comprising of about 800 companies, was valued at US \$ 51 billion in 2018. It is expected to grow at 14.5% in future. Recognizing the opportunity, Indian government is encouraging the growth of the industry through huge grants for research and start ups. It is up to us to utilize the opportunity and get benefited. 


